Meeting Summary

Sharon Powers moved to approve the October 22, 2018 OSTAB meeting summary as presented. Linda Strand seconded the motion. The motion passed (6-0).

General Discussion

Harvest Trail - Gun Club Rd to Harvest Rd Construction

Roger Harvey presented the Harvest Trail, Gun Club Rd. to Harvest Rd, construction funding proposal to OSTAB. The request is for \$2,500,000 in Open Space Acquisition and Development funds to construct the entire segment of trail. The proposed trail will be 10 feet wide and 6,125 feet (1.16 miles) in length with two bridged creek crossings, rest stops, overlooks, landscaping, and a 4 foot wide equestrian trail along the north edge. This will serve as the only off-street connection on the east side of E-470 and the only connection for residents on the west side of E470 to safely get across the E470 highway. The Harvest Trail will directly connect to the Arapahoe County Fairgrounds connector trails and to the Aurora Reservoir via the low-traffic Powhaton Rd. Additional connector trails to the Toll Gate community will also be built to the south.

Dala Giffin motioned to recommend to the BOCC approval of the expenditure of up to \$2,500,000 from the Open Space Acquisition and Development Fund for the construction of Harvest Trail, Gun Club Rd. to Harvest Rd, and for the associated landscaping. Grider Lee seconded the motion. The motion passed (6-0).
