## **Voting is underway for Arapahoe County 2013 Coordinated Election**

*Voters can return ballots with 66-cents postage or deliver to one of 19 drop boxes by Nov. 5*

**Littleton, Colo.** – Mail ballots are arriving in mailboxes to all active registered voters for the 2013 Coordinated Election. Any citizen who is not registered and wishes to cast a ballot must register to vote online by Oct. 28, or in-person at a Voter Service and Polling Center through Election Day, Nov. 5.

“Following a change in Colorado’s election law, all active registered voters will now receive a mail-ballot in every election,” said Arapahoe County Clerk and Recorder Matt Crane. “The County has mailed more than 345,000 ballots so far for this election.”

Mail ballots can be returned by U.S. mail with 66 cents in postage or delivered to one of 19 convenient drop-off locations by 7 p.m., Nov. 5. Visit [www.arapahoevotes.com](http://www.arapahoevotes.com) to request and track your mail-in ballot, as well as find locations and hours for ballot drop-off boxes.

Citizens can visit one of four Voter Service and Polling Centers through Election Day to register to vote, update voter registration, request a mail ballot, request a replacement mail ballot, drop off a voted mail ballot, or vote at an accessible voting machine. These locations will be open Monday-Friday with varying hours through Election Day, as well as 9 a.m. – 1 p.m., Saturday, Nov. 2.

Citizens who desire to register to vote in-person at a VSPC will need to sign an affidavit affirming their identity, address and legal residency and voting age, under strict penalty of law.
