LITTLETON, CO – Members of the news media who will be following the 2012 General Election in Arapahoe County will be able to access election results after 7 p.m., Nov. 6 at www.arapahoevotes.com.

Please use this number for election questions, interview/photo and video requests for Clerk and Recorder Nancy Doty, and for members of the media needing to take photos or video at any of Arapahoe County's 32 Vote Center locations. **Please contact us prior to visiting a Vote Center so we can notify the election judges on-site.**

The news media also may wait for election results on site at our Elections Facility and Warehouse, 5251 S. Federal Blvd., Littleton, CO 80122.
