## **Arapahoe County Treasurer's Office opens property tax drop-off sites**

*Temporary location opens Feb. 22 in Byers, Feb. 25 in Aurora for citizens to drop off tax payments*

**Littleton, Colo.** - The Arapahoe County Treasurer's Office will open two temporary locations for citizens to drop off their property tax payments beginning Feb. 22.

The first temporary drop-off site – at Guaranty Bank – 537 N. Hwy 66, Byers - will open 10 a.m. – 2 p.m., Friday, Feb. 22 for citizens to drop off their current year property tax payments, meet Treasurer Doug Milliken and enjoy a free barbeque. Citizens may make their payments by cash or check.

Guaranty Bank will be accepting property tax payments 9 a.m. – 5 p.m., Monday-Friday through Oct. 31.

In addition, Guaranty Bank has agreed to assist the Treasurer's Office with property tax payments in the future. Property tax payments will be accepted from Jan. 15 - Oct. 31 beginning in 2009.

The second temporary drop-off site - at 14980 E. Alameda Dr., Aurora - will be open 10 a.m. – 3 p.m., Feb. 25 - March 3; April 23 - May 2 and June 11 - June 17. Citizens may make their payments by check or cleared funds (cashier's check, certified check or money order). Cash will not be accepted at the Aurora location.

Citizens may also drop-off their property tax payments at the Treasurer's Office in the County Administration Building, 5334 S. Prince St., Third Floor, Littleton. Citizens may make their payments by cash or check at this location.

“We are offering the two drop-off sites in Aurora and Byers to make it easier for citizens to pay their taxes, especially for our citizens who live out east,” said Treasurer Doug Milliken. “We hope that the temporary sites are successful and make it easier for citizens to drop off their payments.”
