SERVICE OF TWO OR MORE PAPERS

Pursuant to C.R.S. § 30-1-105.5 the Civil Unit is required to charge fees for two or more papers served on the same person or different persons at the same time and place in the same action as follows:

First process served: Highest individual fee and mileage as provided above
Subsequent process served: \$10.00 each.

CIVIL STANDBY

Civil standby requests shall be charged a fee per deputy requested for a minimum of one hour based on the following schedule:

5 or more days notice \$50.00/hour
3-4 days prior notice \$55.00/hour
0-2 days prior notice \$60.00/hour

ZIP CODE BASED MILEAGE FEE SCHEDULE

The zip code based mileage fee schedule is for service of civil process for civil actions by Sheriff Deputies based on roundtrip distances from the Arapahoe County Sheriff's Office Civil Section, 13101 Broncos Parkway, Centennial, Colorado 80112 to the following zip codes, rounded to the nearest mile. Mileage to zip codes other than provided below shall be based on actual mileage distance between the Arapahoe County Sheriff's Office Civil Division and the specific location.
